

## Customer Relationship Summary – Form CRS

#### Introduction

Princeton Capital Management LLC is registered with the Securities and Exchange Commission as an Investment Adviser.

Brokerage and investment advisory services and fees differ and it is important for you to understand the differences. The SEC offers free and simple tools to research firms and financial professionals at <u>Investor.gov/CRS</u> which also provides information tailored to educate retail investors about financial professionals.

## What investment services and advice can you provide me?

Our firm offers the below principal investment advisory services to retail investors which we monitor continuously as part of our standard services:

• Portfolio Management Services

The service listed above includes the provision of continuous advice to a client or investing the client's account based on his/her particular circumstances. Our firm provides discretionary investment for those services. If you invest with us on a discretionary basis, we will buy and sell investments in your accounts without requiring your pre-approval on an ongoing basis until you notify us in writing to terminate the agreement. Although we currently manage some client accounts on a non-discretionary basis, we are no longer offering that service option for any new accounts.

Our minimum account size is \$500,000, however, at our discretion, we make exceptions on a case-by-case basis.

### What fees will I pay?

Our fees are assessed quarterly in advance based on a fixed-percentage of your assets under our management. Our fees are disclosed in our Form ADV Part 1A, Item 5.E. and more fully described in our Form ADV Part 2A, Items 5.A., B., C., and D. Some fees create a conflict of interest described below and in more detail in our Firm's Form ADV Part 2A.

• If our firm charges you asset based fees, more assets in the account will cause you to pay more in fees and therefore we may have an incentive to encourage you to increase the amount of money invested in those accounts.

There are other fees and costs related to our investment advisory services and investments in addition to the principal fees and costs listed above that you will pay directly or indirectly. Examples of the most common fees and costs associated with client accounts could include custodian fees, account maintenance fees, mutual fund fees and other transactional fees and product-level fees. Our firm does not receive any portion of these fees.

**Additional Information:** 

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

**Conversation starters**. Ask your financial professional: – Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?

What are your legal obligations to me when providing recommendations when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Below are examples to help you understand what this means.

- Recommending rollovers from retirement plan assets such as 401(k) accounts to an Individual Retirement Account ("IRA") that is advised by our firm can increase the amount of advisory fees you will pay.
- Arrangements with custodians of your assets also present a conflict of interest due to services that are beneficial to us when we recommend you use them to maintain custody of your financial assets.

**Conversation starters.** Ask your financial professional: – How might your conflicts of interest affect me, and how will you address them?
